Application

LIME, SCALE & RUST REMOVER

- 1. Dilute 1 part BUILDERS KLEEN with 3 parts water (250 ml per litre of water).
- 2. Pour, Foam or Brush solution onto surface and allow to penetrate. Use a brush or deck scrub to agitate soil and assist soil removal.
- 3. Thoroughly rinse with water.
- 4. Repeat if necessary.
