This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

# **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

# **SECTION 5 - FIRE FIGHTING MEASURES**

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

Only small quantities of decomposition products are expected from this product at temperatures normally achieved in a fire. This will only occur after heating to dryness.

#### **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. Suitable materials for protective clothing include Nitrile, butyl rubber, Teflon. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. # **Potential Health Effects**
